

**SUNBURY SQUARE HOLIDAY FLEA MARKET
VENDOR CONTRACT**

Upon signing and returning the reservation to the appropriate sponsoring organization, the vendor acknowledges responsibility to the Village of Sunbury for any and all damages to the square as a direct result of the negligence of the vendor. The Village of Sunbury is not responsible for theft, loss, damages, or bodily injury to the vendor or employees of the vendor. By signing the agreement, the vendor accepts and acknowledges all rules and regulations below:

1. The vendor agrees to pay \$35 per inside space or \$50 per outside curb space for each flea market for a site measuring approximately 15' x 20' each.
2. The vendor understands that reservation of curb spaces is on a FIRST COME FIRST SERVED BASIS. Reservation will be guaranteed if payment is enclosed with signed reservation form until all available spaces have been reserved.
3. Directed vendor parking will begin by 4:30 a.m. on the morning of the flea market. Reservations will be held until 6:30 a.m. Remaining available spaces will be sold to those vendors on the waiting list. Gates will open to the public at 7:00 a.m. All sales conclude at 5:00 p.m. and vendors must leave the square no later than 7:00 p.m. on the date of event.
4. No vehicles weighing over ¾ ton will be parked on the lawn area of the square.
5. All vehicles, displays, and sales must be contained within vendor's purchased space(s).
6. Electric and water hook-ups ARE NOT available.
7. The vendor must supply his/her own tables for display.
8. Vendor MAY NOT MOVE concrete/wood benches on the square.
9. Vendor agrees that there will be no distribution of literature without prior approval of the sponsoring organization.
10. The sale of firearms, live ammunition, live animals, pornographic materials, palm reading, or any game of chance is STRICTLY PROHIBITED.
11. Vendor is responsible for removal of his/her trash from the premises. No bags or containers are to be left on the premises.
12. ABSOLUTELY NO CHEMICALS MAY BE USED ON THE PREMISES OF THE SQUARE.
13. Refunds are guaranteed only up to 15 days prior to the date of the flea market. NO REFUNDS will be given due to weather conditions.
14. To confirm reserved spaces, ONLY CONTACT THE SPONSOR OF THAT FLEA MARKET. (Example: The Boosters CANNOT confirm spaces for Independence Day or Labor Day flea markets.)

ADMISSION WILL BE CHARGED TO THE PUBLIC TO ENTER THE SQUARE. \$1.00 ADULTS AND TEENS. CHILDREN 10 AND UNDER ARE FREE. INTERPRETATION OF ALL RULES AND SITE ASSIGNMENTS SHALL BE AT THE DISCRETION OF THE SPONSORING ORGANIZATION.
